

## TEST AND TRACK DAYS AT MSV VENUES – HOW WE ARE KEEPING CUSTOMERS SAFE **APPLIES FROM MONDAY 12 APRIL**

We have implemented a range of procedures at our venues to minimise the need for contact between people when attending track and test days. These changes are in-line with government guidance and are intended to be both practical and convenient for customers, whilst providing reassurance that we're doing everything we can to keep you safe.

### REGISTRATION

- All pre-event registration has been moved online, in advance. This new check-in system is mandatory and will involve completing an indemnity form electronically
- On arrival, participants will only be required to collect and apply their own wristband. You must observe 2 metre social distancing rules and there will be a queuing system in place to support this
- A member of staff will be present in the wristband collection area, behind a Perspex safety screen, to visually check licences and deal with any issues and queries
- Hand sanitiser will be widely available

### TRACKDAY BRIEFINGS

- Briefings will be online for all trackdays (there are no briefings on test days), accessed as part of the check-in process. The briefing must be watched in full before you collect your wristband, no more than 24 hours before your event
- No wristbands will be issued in respect of briefings

### FOOD AND DRINK

- Our restaurants will be offering a takeaway service with a limited hot food menu and a number of additional safety measures in place
- All customers are welcome to bring their own food and drink to the circuit
- All members of catering staff will be wearing appropriate PPE
- Outdoor (only) seating will be available

### GARAGES AND PADDOCK AREAS

- On trackdays, access will be restricted to one car and two people per single garage (maximum three bikes and three people per single garage on bike events)
- On car test days, access will be restricted to two cars and four people per single garage
- Garages will remain fully open at all times (to the front and rear)
- Additional space in the paddock will be made available to assist with venue-wide social distancing measures

### ADDITIONAL POINTS

- Only participants and one essential helper may attend a track day. No-one else, including spectating friends or family members, will be permitted. Essential helpers must be aged over 16 as children cannot be left unaccompanied on track and test days
- 1-2-1 in-car tuition (by instructors employed by the event operator or on a private self-employed basis) will be permitted, as long as the driver and instructor each have either a full face helmet with visors closed, or open face helmets with a face mask
- On trackdays and test days, up to two additional drivers (three on test days) are permitted however the vehicle must be wiped clean prior to each swapover. Each driver must travel to the venue separately, unless they are from the same household as you or your Support Bubble
- On trackdays, up to two passengers are permitted provided they are aged over 14 (16 at Bedford Autodrome) and from either your household or Support Bubble
- Helmets are no longer available to hire but you can purchase one online from companies such as Alex Reade, Stand 21 and Demon Tweaks
- Access to Race Control will be restricted to essential staff only
- Be advised that circuit management retain the right to pause or stop track activities if health and safety protocols (COVID-19 related or otherwise) are consistently breached
- Participants will be required to wear face coverings when inside venue buildings. Signage will be in place to support this

### OVERNIGHT STAYS

- Overnight camping will be permitted at all venues (except Donington Park and Bedford Autodrome) the night before a trackday or the night between two consecutive trackdays
- Camping will only be permitted for participants and their essential helpers
- Toilet facilities (only) will be available overnight
- Availability of showers will vary – please check with your event operator

**IMPORTANT: You must not attend an activity if you have any symptoms of COVID-19, or you are required to self-isolate under Government guidelines. Please notify your event organiser as soon as possible to discuss re-booking arrangements.**
